Senior financial advisors have not only a demonstrated ability to work in their clients' best interests but also a legal obligation to do so. Therefore, we believe that a select group of ethical, experienced advisors make the best shareholders of an investment company and will provide the clearest recommendations on how to meet the needs of our investors.

Value Partners Group Inc. ("VPGI") is the parent company of Value Partners and is owned by senior financial advisors and by employees of Value Partners. Financial advisors that are shareholders in VPGI stand to benefit from the inflow of client money to the investment funds or private client accounts managed by Value Partners. However, advisors that own shares in VPGI also have a responsibility to provide direction to the management of Value Partners and through their ownership they have a means of supervising and controlling the way investors are treated and their money is managed.

VPGI owns 100 percent of Value Partners and LP Financial Planning Services Ltd. (Lawton Partners), a mutual fund dealer. VPGI is 37.4 percent owned by Longton Ltd., whose shareholders include specified members of the Lawton family including Paul and Sean Lawton. Paul Lawton is an officer of VPGI as well as a director and officer of both Value Partners and Lawton Partners. Sean Lawton is a director, officer and advisor of Lawton Partners.

As of November 01, 2021, advisors of Lawton Partners hold, in aggregate, Class A1 shares representing 19.1% and Class C1 shares representing 5.1% of the common equity of VPGI, being the parent company of Value Partners. In addition, certain advisors of the following dealers collectively hold Class A1 shares representing the respective percentage ownership in the common equity of VPGI, the parent company of Value Partners:
